## MOTORIZED WATERCRAFT AND CAMP RELEASE OF LIABILITY, WAIVER OF CLAIMS, EXPRESS ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

Please read and be certain you understand the implications of signing.

Express assumption of Risks associated with use of Motorized Watercraft and Related Activities

I hereby affirm and acknowledge that I have been fully informed of the inherent hazards and risks associated with this week's outing and participation on and in Camp Woodstock's motorized watercraft and watersports (surfing, wakeboarding, tubing and any water related activities) to which I am about to engage, including, but not limited to:

1. Injuries related to participation in watersports;
2. Heat or sun related injuries or illness, including sunburn, sun stroke, or dehydration;
3. Fatigue, chill, and/or reaction time and increased risk of an accident;
4. Wind shear, inclement weather, lightning, variances and extremes of wind, weather, and temperatures;
5. Collision with any of the following:
  - a. Other participants
  - b. The watercraft
  - c. Other watercraft
  - d. Manmade or natural objects
  - e. Shuttle boat
6. My sense of balance, physical condition, ability to operate equipment, swim and/or follow directions;
7. Collision, capsizing, sinking, or other hazards that may result in wellness, injury, exposure to elements, hypothermia, impact of the body upon water, injection of water into my bodily orifices, and/or drowning;
8. The presence of insects and marine life forms;
9. Equipment failure or operator error

I specifically acknowledge that I have read, understand, and agree to abide by the motorized watercraft operational instructions at all times and that I have been trained in the safe use of water sport equipment to my complete satisfaction, and I am physically/mentally able to participate in the water sport activities to which I am about to engage.

I specifically waive any defense insofar as this contract is concerned that may arise as a result of any state or local law and/or regulation or policy that may impact its enforceability.

## RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of being allowed to participate in the above-described activities, as well as the use of any of the facilities and the use of the equipment of the below listed releases, I hereby agree as follows:

1. To waive and release any and all claims based upon negligence, active or passive, or regular participation in water sport activities;
2. To release Woodstock Rentals and their officers, directors, employees, representatives, agents, and volunteers, and vessels from liability and responsibility whatsoever and for any claims or cause of action that I, my estate, heirs, executors, or assigns may have for personal injury, property damage, or wrongful death arising from the above activities whether caused by active or passive negligence of Woodstock Rentals and/or operators;
3. By entering into this agreement, I am not relying on any oral or written representation or statements made by Woodstock Rentals, other than what is set forth in this waiver.

I hereby declare that I am of legal age and am competent to sign this agreement, or; if I am not of legal age, that my parent or legal guardian shall sign on my behalf. By signing this waiver agreement, I acknowledge that I am in complete understanding of possible risks associated with motorized watercraft, water sports, and water related activities. I accept responsibility for any possible liability and that Camp Woodstock LLC, Brent Russell, Katie Russell and all volunteers are released from any possible liability.

### Rules

- Life jackets must be worn in water at all times regardless of circumstances
- No jumping off sea wall
- No swimming under trampoline
- No fighting
- No destruction of property

All rules are for your safety. If Any of the above rules are broken you can be dismissed from camp without tuition being reimbursed and without permission to return.
